The undersigned petitioner(s) certify that we are owners of the land(s) described on attached Exhibit A and do hereby petition for approval to extend municipal water mains and sanitary sewers to serve said lands.

Petitioner agrees that:

1. If the land(s) to be served by the utilities are not located within the corporate limits of the City of Valparaiso (City),
 - a. Petitioner(s) will submit a Request for Annexation to said City, and
 - b. If the City declines or defers the Request for Annexation but allows the extension of, or connection to, said utilities, petitioner(s) will provide an executed Waiver of Objection and Consent to Annexation to the City;
2. Any utility connections and/or extensions will be designed and constructed according to City of Valparaiso standards with understanding that they will/may become parts of the municipally maintained systems;
3. Approval of the construction plans for said extensions shall be received from the Valparaiso City Utilities (Utility) before any construction of said connection or extensions occurs;
4. The Municipal Inspection Fee (0.50 plf) for a sewer extension will be paid prior to beginning construction;
5. IDEM construction permits shall be applied for, copies of said applications provided to the Utility Director, and permits obtained from IDEM before any construction of said extensions occurs;
6. As a condition of the City's approval of the utility connection or extensions, any new improvements on the subject lands will be presented for comment through the City's Site Review process;

7. Any and all improvements proposed for the site will be developed according to City standards except as provided in any variances obtained from the Board of Public Works and Safety and/or Utility;
8. Either
 - a. Surety, acceptable to the City's Board of Public Works and Safety, shall be provided to guarantee the proper construction of the sanitary sewers, or
 - b. Sewer connection permits will not be issued until the sewer main extensions are constructed, tested and accepted by the City (note that Porter County will not issue building permits until the sewer permits are obtained);
9. A contract with the Utility will be executed providing for the cost and the construction of the water main extension(s);
10. Partial payment, as determined by the Utility and as provided for in the contract, will be made prior to the start of construction of the water main extension by the Utility.
